## Le Sueur County Workplace Lactation Support Grant Final Report

August 2010	Two PH staff attended BCBF training
September 2010	<ol style="list-style-type: none"><li>1) County Board approval to apply for grant.</li><li>2) Sample Lactation Policy given to Personnel Policy Committee for review/implementation.</li><li>3) County departments surveyed re: availability of private space for breastfeeding mothers – no dedicated, private space identified that all employees could use.</li><li>4) Met with Bldg Supervisor to establish space/work plan and cost estimates. Identified an open area near the elevator on 3<sup>rd</sup> floor that could be utilized to build an 8x8x7 foot high cubicle with a locking door.</li></ol>
October 2010	<ol style="list-style-type: none"><li>1) October 11, 2010 applied for MN Workplace Lactation Support grant.</li><li>2) Worked with Personnel Coordinator to develop “Policy for Supporting Breastfeeding Employees.”</li></ol>
November 2010	<ol style="list-style-type: none"><li>1) November 12, 2010 notification from the MN Breastfeeding Coalition that our grant was funded for \$2,000.</li><li>2) Ordered products as budgeted for Lactation room (cubicle, chair).</li></ol>
December 2010	<ol style="list-style-type: none"><li>1) County Board approval on December 21, 2010 to accept the “Lactation/Breastfeeding Policy” for Le Sueur County employees.</li></ol>
January/February 2011	<ol style="list-style-type: none"><li>1) Cubicle built. Chair delivered. Finishing touches including a table, picture and signage completed.</li></ol>

	2) Education to all County employees re: new Lactation Room and the approved "Lactation/Breastfeeding Policy."
Ongoing 2011	Evaluate success through user survey. Additional education to employees on an ongoing basis.
