

## **Seeking Minnesota Breastfeeding Coalition Project Director**

The Minnesota Breastfeeding Coalition (MBC) is seeking a part-time Project Director hired on contract to assist with a CDC 1807 grant awarded from the Minnesota Department of Health Office of Statewide Health Improvement Initiatives to implement interventions supportive of breastfeeding. The outcome is to increase the number of maternity centers implementing supportive breastfeeding interventions as outlined by the WHO's Ten Steps to Successful Breastfeeding (Ten Steps). Project Director reports to the Mother-Baby Healthcare Collaborative Subcommittee.

### Job duties include and are not limited to:

- Identify and recruit maternity centers seeking to implement the Ten Steps to Successful Breastfeeding
- Assist with development of action plans for at least 2 maternity centers to implement any or all of the Ten Steps
- Provide technical assistance to maternity centers either in-person or by phone or other communication method which may include assisting with
  - Development of data collection and analysis template for monitoring breastfeeding metrics
  - o Questions about implementing any of the Ten Steps
  - o Progress towards completion of any of the Ten Steps
- Assist with developing learning collaborative plan for up to 5 maternity centers in 2019
  - Facilitate networking amongst the maternity centers to share best practices, ideas, and resources using conference calls, webinars, Basecamp, and/or listservs
- Identify and facilitate educational opportunities for maternity centers that relate to the Ten Steps
  - Assist with the MBC Perinatal Hospital Leadership Summit planning for May 17, 2019 in collaboration with the Events Coordinators and the Mother-Baby Healthcare Collaborative Subcommittee
- Assist 1-2 maternity centers in applying for 1 star (2 steps) of the Minnesota Department of Health Breastfeeding Friendly Maternity Center Designation Program
- Provide updates to the MBC Steering Committee and Board during regular steering committee meetings and a summary of activities at the conclusion of the contract
- Facilitate partnerships and collaborations with agencies and organizations such as Minnesota Department of Health Office of Statewide Health Improvement Initiatives, Statewide Health Improvement Partnership, WIC, Family Home Visiting Program, public health, the Minnesota Hospital Association, and others
